

* Terms & Conditions

1. Organiser & Eligibility

- 1.1 "Abbott Merdeka Contest" ("Contest") is hosted by Abbott Laboratories (M) Sdn Bhd ("Organiser").
- 1.2 This contest is open to all Malaysian citizens that are 18 years of age and above at the Commencement Date of the Contest except employees, directors, and officers of the Organiser, its agencies (including representatives, advertising, media, event management & vendors/suppliers related to the Contest), subsidiaries, affiliates, related corporations, dealers & retailers, and their immediate family members shall not be eligible to participate in this Contest.

* 竞赛规则

1. 主办单位及参赛资格

- 1.1 “Abbott 国庆竞赛”（简称“竞赛”）是由 Abbott Laboratories（马）私人有限公司（简称“主办单位”）主办。
